

# **Ultimate Supercross Experience Contest**

### 1. Who Can Enter:

Participants must be at least 18 years of age or age of majority at primary residence, have lawful access to the internet and a valid e-mail address. Rocky Mountain ATV/MC employees, family members and any persons living in their household(s) are ineligible. Participants must be legal residents of the United States of America, Australia or Canada. Participants must also be able to provide their own transportation to and from any of the AMA Supercross Events that the winner receives. Each winner will be responsible for any expenses including lodging arrangements and/or costs associated with traveling to any AMA Supercross Event.

## 2. How to Enter:

No purchase is necessary. To enter you will need to fill out the contest entry form on Rocky Mountain ATV/MC's website. Entries must be received no later than three weeks before the AMA Supercross Event(s) that the contestant marked on their entry form as being able to attend. All entries received after the aforementioned time will be disqualified for that round. Each participant will be allowed one entry per household; if a participant is suspected of using multiple e-mail addresses or submitting more than one entry form to better their chances of winning, all suspected entries will be disqualified. Proof of age and residence may be requested and must be supplied before prizes are given. Rocky Mountain ATV/MC is in no way responsible for paying for, arranging, or supplying any transportation, food, lodging or any other expenses related to traveling to and from the event that the participant has won tickets to. Rocky Mountain ATV/MC will notify the winners via the e-mail address or phone number they've supplied in the entry form found on the Rocky Mountain ATV/MC website. Winners will be notified by Rocky Mountain ATV/MC three weeks prior to the Supercross event that they have won tickets for. If there is no response from the winner within one week (7 calendar days) of them being notified, that winner will be voided. The winner will have until seven calendar days (one Saturday) prior to the Supercross event they've been notified they've won, to confirm that they will attend that event. Chosen winners are not able to transfer their tickets to any other round, they may only accept tickets to the round they were originally chosen as winners to.
